Subject: Extension of EPF & MP Act, 1952 on Mahatma Gandhi Kashi Vidyapeeth, Varanasi - regarding.

Sir,

As you are aware that Employees Provident Fund Organisation working under the Ministry of Labour and Employment, Government of India is entrusted with the task of ensuring Social-Security benefits in form of Provident Fund, Pension and Insurance to the employees, engaged by an establishment having 20 or more persons, falling under the eligibility criteria as defined under EPF & MP Act 1952 and are not entitled to any other social security benefits framed by Central/State Governments.

2. As Mahatma Gandhi Kashi Vidyapeeth engages large number of employees on Daily, Casual and Contractual basis, who were not covered under any social security scheme and the University has extend EPF benefits to them. This office is thankful to your good office for making genuine efforts to bring these employees under the purview of EPF and MP Act, 1952.

3. Further, it is also learnt that hundreds of colleges are affiliated to Mahatma Gandhi Kashi Vidyapeeth. Majority of those are still either not covered under EPF & MP Act or have not enrolled all eligible employees. In this regard, a direction from your side to affiliated colleges will facilitate the implementation of statutory provisions under the Act.
